#### WHY AN EA RECONCILIATION APPROACH?

- Because the time is right. Supporting social indicators include:
  - More attention being given to Canada's constitutional principles
  - Over 200 increasingly prescriptive Supreme Court of Canada rulings
  - Numerous federal and provincial policy shifts
  - Growing international trends and obligations (UNDRIP, CBNRM...)
  - A growing number of supporting pilot projects and success stories

### RESOURCE STEWARDSHIP IMPLICATIONS

- Decisions are improved when made closer to the resources
- Decisions are improved when multiple resource sectors are integrated
- Better environmental information improves resource decision-making
- Multi-stakeholder collaboration reduces risk and improves equity
- Ongoing relationship building dialogue helps maintain momentum

### WAHKOHTOWIN EA RECOMMENDATIONS

- Shift towards EA decentralization balanced approach
- Shift towards shared decision-making (FPIC)
- Shift to more precautionary approaches
- Increase the respect for Aboriginal knowledge systems
- Expand the scope of positive and negative effects
- Earlier and increased Aboriginal participant funding
- Integrate the Guardianship process development
- Shift towards shared decision-making

# CONCLUSIONS

- EA as a process is poised to shift in a transformative way
- Aboriginal considerations are paramount to a seamless transition
- There are ways to mitigate the effects of fear of change and public apathy
- Supporting legal, political, moral suasion and other tools are available
- Major expansion of the use of emotional intelligence in EA is required
- Local and regional success stories help fuel provincial/federal policy reform
