Purpose: support the implementation of the *Impact Assessment Act* by providing multidisciplinary research and evidence in the field of impact assessment

Program Objectives:

Create and support research for high quality-assessments (project IA, regional, strategic)

Expand the IA research community

Share information with all groups who can benefit from research results*



Research Output:



- Strengthens the efforts of others to support collaborations between both Indigenous and non-Indigenous communities to the NGO, government and private sector practitioners in IA.




Network on GBA Plus in Impact Assessment
